Shall the Hollister Reorganized School District No. R-5 of Taney County, Missouri board of education borrow money in the amount of \$4,200,000 for the purpose of constructing school facilities including an agricultural education facility, repairing, renovating and improving existing school buildings and facilities, including installing safety and security improvements and technology upgrades throughout District facilities, constructing a crosswalk across State Highway BB, expanding the early childhood center, and furnishing and equipping the same and issue bonds for the payment thereof?

If this proposition is approved, the debt service levy of the school district is estimated to remain unchanged at \$0.821 per one hundred dollars assessed valuation of real and personal property.
